## For the health and safety of our dogs and residents please review the following rules and regulations.

### Dog Park Registration Requirements

1. A registration form must be completed for every dog visiting the park.
2. Registrations and vaccine records must be updated at Town Hall annually.
3. Owners must provide the following: Proof of current rabies vaccine, DHPPV or DHPP (Distemper).
4. At registration, a one-time \$10.00 processing/activation fee will be required for every household.  
Entry cards are not transferable. Replacement fee for a lost card is \$10.00.
5. Homeowners may register a visiting canine at Town Hall. Proof of vaccines/shots are required.
6. Homeowners must accompany the visiting canine registered, to and from the dog park.

Please view a safety orientation video on the Front Porch prior to visiting the dog park.

### General Rules

1. All dogs must be on a leash when entering and exiting the park.  
Owners must carry a leash (6 feet or less) at all times within off leash park areas.  
In order to appropriately monitor your dog(s), only 2 dogs per owner/handler are permitted in either park at one time.
2. Dogs exhibiting aggressive behavior or excessive barking must leave immediately.
3. Do not leave your dog unattended for any reason.  
Direct supervision and voice command control is imperative.
4. The minimum age to enter the park is 16 years of age.  
Children 6-15 years of age may enter with a parent or guardian. For the safety of smaller children, most canine experts suggest children under 6 years of age do not enter dog parks.
5. Keep gates closed at all times. Do not prop or hold open for any reason. Enter and exit swiftly.
6. No running or chasing dogs. Do not pet or play with dogs without owner's permission.
7. Owners/handlers are responsible for clean-up of dog waste in bags and containers provided.

### Safety Standards

For the safety of all the following items are **NOT** permitted in the dog park:

- Food, picnics, glass, alcoholic beverages, smoking
- Rawhides, dog bones, dog food, etc. (Small personal dog training treats are permitted)
- Spike or chain collars
- Dogs with infectious diseases, internal or external parasites
- Female dogs in heat
- Bicycles, strollers, scooters or skateboards (Wheelchairs are permitted)
- Digging: all holes must be covered with dirt before leaving
- Dogs younger than 4 months: they are too young to have all necessary inoculations
- Brushing or grooming dogs within perimeter of the dog park
- Non-registered dogs: Town Hall can issue temporary visitor pass with documentation
- Professional dog training lessons (unless prior approval has been received from Town Hall)

## Release, Hold Harmless, Waiver Liability and Assumption of Risk Agreement

As a condition of use, I understand that the use of the Celebration Dog Park means I am taking and assuming possible risks of injury to myself, my property, my dog and others. I hereby agree to assume these risks and understand that it is solely my responsibility to determine whether the dog park is safe or in my best interest to participate in its recreational use for myself, my property, family members, guests or dog(s).

I/we agree to ASSUME THE RISKS incidental to such usage and on my/our behalf and on behalf of my/our heirs, executors and administrators, and hereby release and forever discharge the Released Parties (LISTED BELOW), of and from all liabilities, claims, actions, damages, costs, or expenses of any nature arising out of or in any way connected with my/our usage of such amenity. I/we further agree to indemnify and hold each of the Released Parties harmless from and against any and all liabilities, claims, actions, damages, cost or expenses, including, but not limited to attorneys and other professional fee disbursements.

I/we further understand that this release and indemnity agreement includes any claims based on negligence, actions or inactions of any of the above released parties and covers bodily injury of myself or pet (including death), property damage, whether suffered by me before, during, or after usage.

This Agreement shall be binding upon me/us and my/our heirs, personal representatives and assignees and shall be governed by and construed under the laws of the State of Florida. This Agreement constitutes the entire agreement among the parties with respect to the subject matter of this Agreement and supersedes any and all previous agreements among the parties, whether written or oral, with respect to such subject matter.

***Those who use the dog park are legally responsible for their dogs and any injuries and/or damages caused by their dogs. CROA reserves the right to prohibit the use of the park to any user who is in violation of the general rules, safety standards or requirements stated. Thank you.***
