Scene Philosophy

How it works

With a traditional fireworks display, there is an opener, main portion (body), and a grande finale. If you have ever ridden a roller coaster, the sequences of the ride compliment each other, leaving a smile on the riders' faces. Fireworks are no different. Our productions will make you XTREMELY satisfied, yet always wanting more of the intensity over and over again. You should always want to come back to us for more, just like a roller coaster!

Opener

Whether you are wanting to start off strong, or ease into the intensity with music, your audience will be captivated from the launch of the first shell. Both options are very popular with our clients on how their audio is mixed. Everyone is different and we tailor to their specific needs.

<u>Body</u>

This is the main portion of your display. The music is flowing flawlessly and then, BAM! There is an exciting hit to intensify a portion of the song(s). There are many effects that can be used from single strip hits, large arrays of large arial shells, large arrays of close proximity or single strip hits with large arial shells to give it dynamic, from slow scenes of falling leaves and twitter glittering shells.

Grande Finale!!!

The time has come! Prior to the finale, we slow it down... to start the intense build up. Our finales are second to NONE. We are known for how large, how intense, how loud, and how widespread our finales are. From starting to the smallest caliber shell, increasing shell size without a smaller size die out, we begin from the center. Then it fans our to multiple angles, multiple calibers, and cakes. We end with a very intense "wall" of salutes and end with a nice colorful or specified colored "splash" after the finale ends! No other company's finale can compare to what we do! Your audience will be begging for more each and every time.

What is Dead Air?

REAL Dead air is taboo in our industry. There are two types of Dead air.. Intentional and Unintentional. With that being said, there will never be "unintentional dead air" or "unintentional black sky" during our display. Intentional dear air happens when you highly choreograph to audio, so do not be afraid of those types. This can intensify the next scene in a pyromusical to give it the wow factor we all look for! If your display has no audio, shells will be firing simultaneously either from a straight angle position, multiple angles positions, multiple calibers angled, and so forth.



Safety Protocol

Safety of the audience and our technicians is our #1 priority. For every display, we have a specific safety plan implemented to ensure the safety of the audience and our technicians as well as environmental matters. We conform to the federal, state, and local safety regulations by obtaining all necessary permitting and approvals.

Technicians will always take the necessary precaution before firing a show by doing a final walk through with the fire marshal as he gives approval for firing. Any water-based displays, technicians will have proper personal flotation devices on, at all times. NO EXCEPTIONS. During firing of the show, our techs will have the proper PPE for eyes, ears, feet, and head. Smoking is strictly prohibited within 100 feet of a firing site or fireworks. Cell phone usage will be kept to a minimum in the immediate blast zone to keep radio frequencies down.

A Mandatory "morning after" walk will be conducted throughout the firing zones, fall out zones, spectator viewing area, and any other surrounding areas for unexploded ordinances and excessive debris. Any unexploded ordinances will be packages and secured to comply with Federal DOT regulations.

Xtreme FX is fully insured and certified in creating and performing display shows as well as special effects shows. Xtreme FX includes five million in general liability for each event as well as an additional five million in vehicle insurance. Any driver who drives HAZMAT for Xtreme FX has a commercial driver's license and HAZMAT training. We take pride in knowing our insurance is through one of the best agencies in the industry.

Most companies still today perform hand fired displays. Xtreme will not accept or perform any hand fired displays due to safety of our technicians. We use the highest technology in firing systems to ensure safety of everyone involved. Making this a policy for our company, we have came to find that the clients, fire departments, and our employees feel more comfortable with being away from the immediate blast zone.

We take pride in our safety record. Xtreme Fx has had zero insurance claims, zero federal fines, and zero state fines. Safety is our number one priority and our record proves that!



<u>Xtreme FX</u> carries five million dollars in general liability insurance that is maintained through a one year policy. Our insurance covers all product and completed operations. The policy is "per occurrence" instead of "per claim." We also carry 5 million commercial automobile insurance required by USDOT as well as comply with Workers compensation state statutory limits.



Layering is quite simple and one of our specialties. Different calibers burst at different heights as pictured above. Shells per caliber, burst at approximately 100 feet for every inch in diameter. To get a better understanding, a 3" shell will burst at a height of approximately 300 feet.

2" = 200' 3" = 300' 4" = 400' 5" = 500' 6" = 600' 8" = 800' 10" = 1000'

In our inventory, we do not have all basic shells. For example, a lot of red and green peony. These colors and effect are the quickest and cheapest to make. Below are some of the effects we utilize in every show to create an "over the top" display each and every time.



CLIENT SERVICES AGREEMENT

This Client Service Agreement (the Agreement) is made on this <u>day of January 2024</u> by and between Xtreme FX, LLC, an LLC formed under the laws of the State of Florida, with an address of 1381 Market Circle #4, Port Charlotte, FL 33953 (XFX), and Celebration Community Services an individual/business residing in the State of Florida with an address of, 851 Celebration Ave.

Celebration, FL 34747 (Client) (Collectively "the Parties").

This agreement includes display show for the dates stated: July 4th, 2024 for a total of \$35,000.00

WHEREFORE, XFX is a special effects company that is in the business of providing customized visual

and audio effects as requested.

NOW THEREFORE, In consideration for the mutual promises and covenants contained herein, and other good and valuable consideration, The Parties agree as follows:

- 1) Services. XFX shall provide the Services described in Schedule A attached (the "Services") at the prices agreed upon therein. Clean-up shall be provided by XFX except for Confetti, Paint and Foam, unless specifically agreed upon and included in Schedule A.
- 2) Term Agreement. The term of this Agreement (the "Term") will begin on the date of this Agreement and will remain in full force and effect until the completion of the Services, subject to earlier termination terms as provided in this Agreement. The Term of this Agreement may be extended by mutual written agreement of both parties.
- 3) Payment Arrangements. 50% of total amount is due within 7 calendar days upon execution of this contract. Remaining balance shall be paid within 7 days of the display date. Any payment made past the due date will incur a 10% fee on the deposit in which is late.
- 4) Cancellation Policy. Any cancellation prior to end of agreement will result in the initial deposit nonrefundable due to expenses incurred by XFX. Cancellations must be received within 45 days of event. Any Rain out dates or rescheduling will be available but must be accepted by XFX. Any
- 5) Postponement. Postponements cannot be made at this time without any reschedule fee incurred. Any postponements that are not agreed upon will result in a \$2500.00 reschedule fee due to expenses incurred.

- 6) Privacy Policy. All personal and credit card information will remain confidential. XFX will not sell or distribute any information about our clients.
- 7) Returned Check Policy. A \$100 fee will be assessed on all returned checks. This fee plus the amount of the original check is due promptly and must be paid via money order, certified funds, cash, or credit card.
- 8) Inclement Weather. In the event of inclement weather on date of event, dependent on the severity, XFX will perform the services in an open window with no rain, lightning, high seas, and high winds over 20mph. In the event there is severe weather such as lightning, driving rain, high winds over 20mph, high seas, and any other Acts of God that would limit the performance or safety, XFX agrees to a rain out date agreed upon by both parties for a nominal fee of hotel stay, truck rental, and labor costs. In the event the display is cancelled, there will be no deposit refunded due to incurred expenses.
- 9) Government-Imposed Tariff. In the event any government- imposed tariffs affect product cost and shipping, the City will be responsible to compensate Contractor for the percentage of the tariff increase for entire show cost for the years affected in this agreement. Shipments under this Agreement shall be subject to, and the Parties shall be required to comply with, the provisions of any applicable governmentimposed Tariff.
- 10) Assumption of the Risk. Client understands that due to the nature of the equipment and how each effect is achieved, that there is an inherent potential risk of injury, accident or illness at any venue where services are to be performed. A list of potential effects for each effect listed in Schedule A has been provided to client, which client acknowledges receipt of by signing this agreement. Client also agrees that they will abide by any instruction or command given by any XFX personnel on site at the venue that relates to any safety issue.

11) Insurance

a. Xtreme FX, LLC shall, throughout the performance of its Services pursuant to this Agreement, maintain:

(i) Occurrence basis comprehensive general liability insurance (including broad form contractual coverage) and automobile liability insurance, with minimum limits of \$1,000,000, respectively, combined single limit per occurrence, protecting it from claims for bodily injury (including death) and property damage which may arise from or in connection with the performance of Xtreme FX, LLC services under this Agreement or from or out of any act or omission of Xtreme FX, LLC, its officers, directors, agents, and employees; and

(ii) Workers' compensation insurance as required by applicable law (or employer's liability insurance with respect to any employee not covered by workers' compensation) with minimum limits of One Hundred Thousand Dollars (\$100,000) per occurrence.

b. All such insurance required in Paragraph a. shall be in companies and on forms acceptable to Client and shall provide that the coverage thereunder may not be reduced or canceled unless thirty (30) days prior written notice thereof is furnished to Client. Certificates of insurance (and copies of all policies, if required by the Client) shall be furnished to Client. In the event of any cancellation or reduction of coverage, Xtreme FX, LLC shall obtain substitute coverage as required under this Agreement, without any lapse of coverage whatsoever."

12) Termination. This agreement may be canceled by either party in writing, subject to the provisions of Paragraph 3. Terms must be agreed upon by XFX and signed.

Notices. Any notice, demand, consent, election, offer, approval, request, or other communication (collectively a "notice") required or permitted under this Agreement must be in writing and either delivered personally or sent by certified or registered U.S. mail, postage prepaid, return receipt requested to the address appearing on the first page of this agreement, or by e-mail to **NicoleJ@xtremespecialeffects.com** if to XFX, or by e-mail Liz.wargo@grandmanors.com if to Client. Any E-mail sent will be deemed to be received by the next business day.

- 13) Separability of Provisions. - 15) Legal Expenses. In the event legal action if brought to enforce or interpret any term of this Agreement, XFX will be entitled to recover, in addition to any other damages or award, all reasonable legal costs and fees associated with the action.
- 16) Controlling Law. - 20) Motorized Golf Carts. At least TWO motorized golf carts or Maintenance Cart will be required by XFX at client's expense. Fireworks equipment will be set up UP TO TWO DAYS prior to the event. The cart will be utilized the entirety of the set up and tear down times.






Pyrotechnic Effect Definitions

Brocade – A spider like effect in the sky, much like fine lace. The brocade effect is generally a golden tail effect, and is brighter than the willow or tiger tail effect. Most brocade effects use glitter to produce the long brocade tails.

Chrysanthemum – A flower-like aerial pattern, usually resulting from a cake or mortar.

Comet - A type of star that leaves a long trail of sparks as it flies through the air.

Crossette - A type of comet that breaks into multiple comets, usually forming a cross shape.

Pearls – Bright balls of color that fly through the sky and burn themselves out after reaching maximum height.

Dragon Eggs – A delayed crackle effect displayed in egg-shaped patterns with loud crackle near the end.

Waterfall - Glowing embers that fall slowly in the air, creating a willow or waterfall effect.

Flying Fish – An aerial effect that looks like a swarm of objects squirming though the air. This effect usually lasts only a few seconds. Fish are a type of fuse that propels itself through the air, creating a swimming effect.

Palm Tree – An aerial effect that produces a gold or silver stem as the shell rises into the sky (known as a rising tail), followed by a brocade or willow effect that creates palm fronds. It resembles a gold or silver palm tree in the sky.

Peony – An aerial effect that looks like a spherical ball of colored lights in the sky. A very common aerial effect on most fireworks displays.

Ghost - An aerial effect that creates a disappearing and re-appearing color trail new to the fireworks industry.

Rising Tail - A rising tail is a gold or silver tail effect that is created when a shell is shot into the sky, similar to the



shell is shot into the sky, similar to the trunk of a tree. Commonly used with palm tree shells.

Strobe – A strobe is a blinking effect. When used in a shell with hundreds of strobe stars, the strobe effect looks like shimmering water in the sky. Strobes can be a variety of colors, including white, green, blue, and orange.

Tourbillion – Another name for a serpent. A tourbillion is a type of star that spins in the sky and gives off large quantities of gold, silver, or white light.

Willow – An aerial effect that looks like a giant gold willow tree in the sky. A true willow effect has delicate golden trails that hang in the sky ten seconds or more.

Pattern - An aerial effect Including but not limited to Smiles, Hearts, Squares, Diamonds, Stars, 3D Cubes always a crowd pleaser

- 1. Sponsor to make a deposit payment of 50% of the contract price upon signing of contract. If the display is being contracted within 30 days of display date, deposit payment is due immediately to ensure enough time to acquire permits. PERMITS WILL NOT BESECURED FOR THIS EVENT WITHOUT DEPOSIT PAYMENT BEING RECEIVED. Balance Payment due 14 days prior.
- 2. In the event Sponsor shall fail to pay any sum when due under the terms of this contract, Sponsor shall pay, in addition to such amount, interest at the rate of 1.5% per month on the unpaid amount from the original due date. Sponsor does further agree that it shall pay Explosive Touch Enterprises, LLC. reasonable attorney fees and court costs in the event Explosive Touch Enterprises, LLC. shall commence suit or incur fees to compel Sponsor to pay any sums due hereunder or otherwise as a result of Sponsor's default of any of the terms and provisions herein contained.
- 3. If event is on land, sponsor to furnish police and/or crowd security personnel, provide proper parking supervision, and insure adequate patrol of the safety zone as marked and secured by the sponsor until Explosive Touch Enterprises, LLC advises that it is no longer required. Explosive Touch Enterprises, LLC is not responsible for clean-up of extended range debris for land-based shows other than c ompany equipment, supplies and packing materials. A land based fireworks display will produce an extended range debris field depending on wind speed. Sponsor shall be responsible for the clean-up of any such debris.
- 4. If event is over the water, Explosive Touch Enterprises, LLC will be responsible for marine event permit, and for the control of safety zone.
- 5. Explosive Touch Enterprises, LLC reserves the right to stop the display in the event persons, vehicles or animals enter the secured safety zone and security is unable or unwilling to remove them and enforce the safety regulations.

If for some reason, shoot time does not occur before the allotted time and shoot is canceled due to local authority or expiration of permit, Sponsor is liable for full payment of display.
- 8. Sponsor holds Harmless Explosive Touch Enterprises, LLC from any claims that do not directly relate to damages produced by Explosive Touch Enterprises, LLC's staff, equipment or pyrotechnic material. The Sponsors agree to give Explosive Touch Enterprises, LLC prompt notice of any claims or demands and to cooperate with Explosive Touch Enterprises, LLC or its successors in interest or assigns, if any, in the defense of any such claims and/or demands. Additionally, if the aforementioned cancellation occurs, sponsor will be responsible for load in/ load out expenses not to exceed 50% of budget. In the event a reschedule occurs and is unrelated to the actions or inactions of Explosive Touch Enterprises, LLC or its staff, and additional fees are incurred by Explosive Touch Enterprises, LLC such as permitting, fire watch, police, barge, etc, Sponsor will be responsible for these fees as they are automatically charged to us.
- 16. Sponsor agrees to notify Explosive Touch Enterprises, LLC of any unknown changes of said fireworks display such as change of venue, change of time or any other unknown change a minimum of 14 days prior to display date. If for any reason an unknown change does not allow for the setup and execution of fireworks display, sponsor is responsible for 50% deposit.
- 17. Client agrees to provide Explosive Touch Enterprises, LLC with an adequate firing area that is necessary to produce a safe fireworks program. If for any reason on the day of display the firing area is considered unsafe (Ex: Flooding/Standing water is present, muddy terrain or other hazards) to execute the fireworks display, Sponsor is still liable for 50% of Show Budget.
- 18. If Sponsor has accepted a pre-payment discount offer at signing of contract, sponsor understands that if for any reason sponsor cancels fireworks display, that 50% of the pre-payment amount is forfeited.
- 19. <u>Marketing</u>: Explosive Touch Enterprises, LLC may use public displays for promotional use, including but not limited to videotaping and providing invitations to current and/or potential customers to view the display setup site and the fireworks display. For private displays, Explosive Touch Enterprises, LLC will seek approval from Sponsors before making such invitations. In return for marketing privileges, Explosive Touch Enterprises may donate products and services to enhance the display.
- 20. <u>Force Majeure</u>: Explosive Touch Enterprises, LLC will take all reasonable steps to complete its obligations under this contract. However, Explosive Touch Enterprises, LLC shall not be held responsible for failure to perform its obligations under this contract if such failure is a result of an act of God including extreme weather, natural disaster, terrorism, war, or any extraordinary circumstance beyond its control.
- 21. <u>Default:</u> If Sponsor fails to timely perform any of its obligations under this Agreement, Sponsor shall be in default and Explosive Touch Enterprises, LLC shall be entitled to pursue all remedies available under Florida law or equity. THIS CONTRACT ("Contract") is made on this <u>12th</u> day of <u>January</u>, 2024, between GARDEN STATE FIREWORKS, INC., hereinafter known as and designated as

"Garden State; and Celebration Community Services, hereinafter known as and designated as "CCS."

WITNESSETH: For and in consideration of all mutual covenants and agreements hereinafter entered into, the Party and Parties hereinafter agree to a Contract as follows:

1. "Garden State" agrees to furnish "CCS" at a location on the sidewalk behind the lake in Celebration on the 4^{th} day of July, 2024, in a location to be designated by "CCS" and approved by "Garden State" and governing officials, an exhibition of fireworks.

2. "Garden State" agrees to pay all expenses for the freight and cartage for the said display, all necessary labor and equipment, and experienced and licensed Pyrotechnic Operators to discharge the said display. "Garden State" agrees to clean the debris on the site location to the best of their ability.

3. "Garden State" and "CCS" agree to a rain or shine performance of said event. In the event that excessive winds prevent safe firing of the display there will be a daily postponement fee equal to ten percent of the total contract and "CROA" will provide overnight security commencing at 5pm and ending at 8 a.m. for any postponement days.

4. "Garden State" agrees to supply insurance coverage in the amount of <u>FIVE</u> <u>MILLION DOLLARS</u> for public liability and/or property damage and vehicle insurance in the amount of <u>FIVE MILLION DOLLARS</u> as required by the New Jersey Department of Transportation. "CCS" agree to hold harmless "Garden State" of all and any claims, legal fees incurred outside the operations or control of "Garden State." "Garden State" agrees to hold harmless "CCS" from all claims and legal fees incurred from the operations of "Garden State." At least ten (10) days prior to July 4th 2024, "Garden State" shall supply to "CCS" a Certificate of Insurance showing them as the Certificate Holder.

5. "CCS" agrees to furnish ample security or police protection and barricades to prevent any persons from coming into the safety zone area designated for discharging said fireworks display. "CCS" also agrees to barricade and post proper signage at both bridges on either side of the lake to prevent pedestrian traffic for the entire day and night of both July 3rd and July 4th. "CCS" agrees to post a security guard or police officer for an over night watch shift of fifteen (15) hours commencing at 5pm on July 3rd and ending at 8am on July 4th. Additional security is required for the evening of July 4th. On July 4th, "CCS" agrees to arrange for two police officers, one stationed at each of the above-mentioned bridges commencing at 6pm and ending half an hour following the display. With the exception of conditions stated in paragraph 4 above, "Celebration" also agrees to assume sole responsibility for spectator safety, including seating, lighting, and ground

surfaces, and agrees to conduct an inspection of the site approximately 24 hours in advance of the display to ensure a safe spectator environment.

6. "CCS" agrees to pay for any and all permits and 'fire watch' required by municipal authorities for the discharging of the said fireworks display at their own expense. Garden State will complete the application process and bill "CCS" for permits and fire watch fees at cost. The anticipated permit/fire watch costs are approximately \$800.00.

7. "CCS" agrees to coordinate and provide "Garden State" at least two (2) mule carts and adequate trailers to haul the pyrotechnics and equipment from the parking lot to the launch site. This equipment must be the equivalent of the equipment that has been provided for prior annual July 4th events. Said equipment must be made available to "Garden State" on the morning of July 2nd through completion of the event and clean up of equipment.

8. Upon execution of the contract a \$17,500.00 deposit is due and payable to "Garden State" on or before February 6, 2024. "CCS" is responsible for ensuring payment of the deposit. If the event is canceled due to Covid restrictions the deposit will be applied to a future event within 180 calendar days of the display date. If a postponement date exceeds 180 calendar days a 20% rescheduling fee will be deducted from the deposit for carrying costs.

9. Upon delivery of the said display, the full balance of the contract amount shall be paid by 'CROA' to the pyrotechnic operator for "Garden State" in a sealed envelope either before or immediately following the discharging of the display.

10. The total Contract amount is \$35,000.00 United States Dollars. The display will be choreographed to a musical soundtrack of patriotic and popular music approved by "CCS" The display duration will be approximately seventeen minutes.

We look forward to the opportunity to return to exhibit our skill, technology and techniques for this prestigious event.

For over one hundred and thirty years we have maintained a commitment to excellence and treat each display with an artistic attention to detail and budget. We are a New Jersey based firm however, we perform displays throughout the country and world. We operate major satellite offices in California, Nevada and Florida.

Scope of Work

I. Technical Capability

GARDEN STATE FIREWORKS, INC. will provide a first class display lasting 17 minutes in duration. Our production will include all transportation, set-up, firing and clean up of the site area. Our experience producing thousands of events of this scale is valuable to our understanding the demands of the process. We understand the scope of work and the task at hand and we will execute a safe and timely production schedule that will yield a breathtaking display.

A. Show Design Process

The design process is the foundation of the display and the blueprint to dozens of man hours our team will pour into the preparation and execution of the display. The design team will be comprised of our designer, Chris Santore and our production manager August Santore, Jr. Both Chris and August are responsible for the design of our largest displays in the country including annual productions for July 4th in Washington D.C. for 2013 through 2023. We have a style and a vision that informs us but we also pride ourselves on our ability to work collaboratively.

II. Display Location: Side-walk at Lake Rianhard

A. Site Lat/Long: 28°18'56.4"N 81°32'22.0"W

Based on review of the site and our experience at the venue, the sidewalk on Lake Rianhard is the best location for the display. The area will support a display up to 6" aerial display shells. Displays shells of this size and magnitude will provide high impact at viewing distances over to 2,000 feet away from the launch location. If it is determined that the site does not support 6 inch caliber display shells, the production would be scaled down to 5 inch aerial shells. (

III. Fireworks Display

- **A. Compliance:** Garden State Fireworks, Inc. is prepared to conduct a spectacular display for the Town of Celebration. We will comply with local guidelines, NFPA and D.O.T. guidelines for manufacture, transportation, storage and execution of the display.
- **B. Permits:** Garden State Fireworks, Inc. will assist with permit process as necessary. Garden State Fireworks, Inc. will attend any necessary site meetings to assist with approvals. The actual cost of the permits and any additional hourly police or fire official fees are the responsibility of The Town of Celebration. Permit costs, fire watch/standby vary from city to city and is not covered in our proposal. Site security costs are also the responsibility of the Town of Celebration.

C. Visibility and Impact: We have specific experience creating displays for audiences for events around the country. We understand the importance of entertaining the audience at all distances and vantage points. The proposed launch location caters to a wide audience viewing area and will have great impact for the intended viewing area.

D. Equipment and Safety:

1. Mortars and Mortar Racks

Garden State Fireworks, Inc. utilizes custom built mortars and mortar racks that exceed industry standards. We do not use cardboard or fiberglass mortars as both have inherent strength issues. We use HDPE mortars that are more expensive and heavier but are superior in strength and durability. The mortar set up team will also set up all mortar racks for shell sizes 3" - 6". All mortars will be re-inspected and all set up construction will be final inspected to ensure all equipment is stable and ready for the loading phase. Once the mortars are set, all mortars are if weather is a concern, mortars are covered with protective plastic to prevent rain water from getting into the mortars.

2. Site Plan and Mortar Separation Distances.

Garden State Fireworks, Inc. will adhere to the NFPA guidelines for table of distances for the placement of the mortars and pyrotechnics and each venue. Measuring wheels, tape measures and range finders are used in conjunction with the site plan to place mortars well within the tolerance of the table of distances. Site plans for the proposed location are included in this proposal.

E. **Inclement Weather:** We make certain we are well prepared to deliver on time and will be well prepared for weather delays or postponements. Garden State Fireworks, Inc. will work with The Town of Celebration to monitor the weather and make an intelligent decision to postpone based on the weather and safety factors pertaining to same. Garden State Fireworks prepares for all weather conditions. If the weather conditions at launch time are deemed safe to perform, we will be ready rain or shine.

F. Town of Celebration Requirements

1. The Town of Celebration would be responsible for ensuring the safety zone is secured and that adequate police, fire and EMS are in place to maintain the safety perimeter as well as maintain the audience viewing areas. Garden State Fireworks, Inc. will apply for fire permit.

2. The Town of Celebration would be required to secure the launch site from July 3rd through completion of the event including overnight security.

G. <u>Pyromusical:</u>

Pyromusical displays are the highest form of the pyrotechnic art. The emotional impact of the combination of sight and sound reaches intensity levels that most mediums cannot dream of and we treat it accordingly. Our many years of delivering such displays have helped us hone our craft in such a way that from the first beat of the music we grab the audience and pull them on a roller coaster ride of sensory overload.

- **a.** A 'Sound' Approach: Our approach to a musically choreographed display is driven by an intense focus of interpreting the soundtrack in a clear emotionally connected visual that the audience can readily perceive. An aerial fireworks display is governed by the distances to the audience by NFPA guidelines. Our knowledge of the proposed firing locations for the aerial displays indicate that the proposed venue supports aerial display shells up to a total size of 6" display shells. In the event final venue review does not support a maximum size 6" aerial display shell, the program will be adjusted accordingly to maximize the impact at that venue.

- B. Aerial Display Shells Types: We will draw from our very diverse library of effects to deliver the most impressive display possible. We are confident our product library and diversity exceeds our competitors. Aerial Shells will range from 2" to 6" display shells.

All lead technicians carry the proper NJ license for displaying pyrotechnics using electric matches if electric firing is part of the production.

All pyrotechnicians will meet all federal, state and local guidelines and adhere to NFPA guidelines for proper safe display set up and execution. All pyrotechnicians will have ATF background checks. Sub-contractors will not be used for any portion of the production.
