# Welcome to the Celebration Dog Park!

The park is for the sole use of Celebration Residents and their four-legged friends!

Time varies throughout the year, please check the Celebration website for updates. For the health and safety of our dogs and residents, please review the following rules and regulations.

**Note: Cameras are in use to monitor the dog park at all times.**

**Please view a safety orientation video on the Celebration website prior to visiting the dog park.**



## **Dog Park Registration Requirements**

- 1. A registration form must be completed for every dog entering the park.**
- 2. Residents must register all visiting dogs at Town Hall.**
- 3. A Celebration resident must accompany registered visiting dogs during park visits.**
- 4. Proof of vaccines/shots are required for all residents and visiting dogs.**
- 5. Registrations and vaccine records must be updated at Town Hall annually to include: Proof of current rabies vaccine, current DHPPV or DHPP (Distemper) & fecal test.**
- 6. A one-time \$10.00 processing/activation fee will be required for every household. Replacement fee for a lost dog park ID card is \$10.00. Entry cards are not transferable.**

## **Rules and Regulations**

- 1. No animals other than registered dogs are permitted in the dog park.**
- 2. All dogs must be on a leash until they enter the gated areas of the dog park.**
- 3. Owners must carry a dog leash in off leash park areas at all times. It is recommended that all dogs are unleashed once inside the dog park.**
- 4. Keep gates closed at all times. Do not prop or hold open gates. Enter and exit swiftly.**
- 5. Residents are responsible for cleanup of dog waste in bags and containers provided. Failure to pick up after your dog may result in loss of dog park privileges.**
- 6. In order to appropriately monitor your dog(s), only two (2) dogs per supervising resident are permitted in the park at one time.**
- 7. Do not leave your dog unattended for any reason. Direct supervision is imperative, keep an eye on your dog at all times.**
- 8. Dogs exhibiting aggressive behavior must be removed immediately.**
- 9. It is recommended that unneutered dogs not be brought into the dog park.**
- 10. Female dogs in heat are not permitted in the dog park.**
- 11. A resident entering the park must be 16 years old or older.**
- 12. Children 6-15 years of age may enter with a parent or guardian. For the safety of smaller children, children under the age of six are not permitted in the park.**
- 13. Do not allow entry to anyone who does not have a valid and active Dog Park ID card.**
- 14. Do not run or chase dogs. Do not pet or play with dogs without owner's permission.**
- 15. Large dogs are not permitted in the small dog park. Smaller dogs entering the large park do so at their own risk.**
- 16. Any resident supervising a dog or dogs pursuant to these rules must be sufficiently experienced to safely handle the dog(s) in the Dog Park environment.**

**For the well-being of all, the following are NOT permitted in the Dog Park:**

1. Dogs with an illness or infectious disease (i.e., flu, diarrhea, vomiting, internal or external parasites)  
Do not return to the dog park until illness has been resolved.
2. Animals other than registered dogs.
3. Dogs younger than four (4) months. They are too young to have all necessary inoculations.
4. Brushing or grooming dogs.
5. Food, glass containers, alcoholic beverages, smoking.
6. Rawhides, dog bones, dog food, etc.
7. Sharing dog treats or leaving treats on the ground.
8. Spiked or chain collars.
9. Bicycles, strollers, scooter or skateboards. Wheelchairs are permitted in dog park.
10. Digging. All holes must be covered with dirt before leaving the dog park.
11. Professional Dog Training lessons. Please contact Town Hall for approved and certified dog trainers in Celebration.

**It is imperative that the owner pick up dog waste for the health and safety of all who visit the park.**

Water bottles and small personal dog treats are permitted.

This park is designed for our four-legged friends. Please refrain from bringing in sporting equipment.

**In the event the dog park rules and regulations are violated or a complaint is filed and substantiated, CROA has the right to suspend or prohibit the use of the dog park by a resident or canine.**

### Release, Hold Harmless, Waiver Liability and Assumption of Risk Agreement

I hereby agree to assume these risks and understand that it is solely my responsibility to determine whether the dog park is safe or in my best interest to participate in its recreational use for myself, my property, family members, guests or dog(s).

I/we agree to ASSUME THE RISKS incidental to such usage and on my/our behalf and on behalf of my/our heirs, executors and administrators, and hereby release and forever discharge the Released Parties (LISTED BELOW), of and from all liabilities, claims, actions, damages, costs, or expenses of any nature arising out of or in any way connected with my/our usage of such amenity. I/we further agree to indemnify and hold each of the Released Parties harmless from and against any and all liabilities, claims, actions, damages, cost or expenses, including, but not limited to attorneys and other professional fee disbursements.

**\*\*The released parties are the Celebration Residential Owners Association, Celebration Joint Committee, Celebration Nonresidential Owners Association, Inc., Celebration Community Development District, Enterprise Community Development District, GrandManors officers, directors, employees, agents, representatives, successors, and assignees of each and every one of the foregoing entities.**

I/we further understand that this release and indemnity agreement includes any claims based on negligence, actions or inactions of any of the above released parties and covers bodily injury of myself or pet (including death), property damage, whether suffered by me before, during, or after usage.

This Agreement shall be binding upon me/us and my/our heirs, personal representatives and assignees and shall be governed by and construed under the laws of the State of Florida. This Agreement constitutes the entire agreement among the parties with respect to the subject matter of this Agreement and supersedes any and all previous agreements among the parties, whether written or oral, with respect to such subject matter.

**Those who use the dog park are legally responsible for their dogs and any injuries and/or damages caused by their dogs. CROA reserves the right to prohibit the use of the park to any user who is in violation of the general rules, safety standards or requirements stated. Thank you.**
